31 December - New Year’s Eve: Exchange: trading system maintenance, statistics, and data migration; Bank: early closure due to end of year procedure.

Slovakia

24 December – Christmas Eve: Stock Exchange and Banks are closed. Local payment system and CSD are open. Depository service is restricted to settlement of instructions in settlement system and electronic submission of requests to Information System.

25 December – Christmas Day: Stock Exchange, CSD, Banks and payment systems are closed.

Slovenia
