**9 June – Whit Monday:** Stock Exchange, CSD, Payments and Banks are closed.

#### Romania

**9 June – Orthodox Pentecost:** Stock Exchange, CSD, Payments and Banks are closed.

**11 June** – Due to the forthcoming public holiday in Russia AO UniCredit Bank's cut-off time for custody instructions will be 16:30 (Moscow time).

**13 June – Declaration of Russian Sovereignty's Holiday:** AO UniCredit Bank will be closed and will resume its normal operations on June 16, 2025. Stock Exchange and CSD will be open with limitations.
