29 May – Ascension Day: Settlement supported by UCBA (against and free of payment)



#### Bosnia and Herzegovina

**1 May – Labour Day:** Stock Exchange, CSD, Payments and Banks are closed.

2 May – Labour Day: Stock Exchange, CSD, Payments and Banks are closed.

**9 May – Day of the Victory over fascism:** Republic of Srpska holiday only. Neither trading on BLSE nor settlement in RS will take place. This is a normal working day for the market in Federation of BiH.

#### Bulgaria

**1 May – Labour Day:** Stock Exchange, CSD, Payments and Banks are closed.

6 May – St.George's Day: Stock Exchange, CSD, Payments and Banks are closed.

**26 May – Public Holiday:** Stock Exchange, CSD, Payments and Banks are closed. Day of the Holy Brothers Cyril and Methodius, of the Bulgarian Alphabet, Education and Culture and of Slavic Literature is on the 24th of May. When an official holiday is on a weekend's day, the following working day is declared public holiday.

#### Croatia

**1 May – International Workers' Day:** Stock Exchange, CSD, Payments and Banks are closed.

30 May – National Day and Corpus Christi: Stock Exchange, CSD, Payments and Banks are closed.

## Czech Republic

1 May – May Day: Stock Exchange, CSD, Payments and Banks are closed.

8 May – Liberation from Fascism: Stock Exchange, CSD, Payments and Banks are closed.

#### Hungary

1 May – Labour Day: Stock Exchange, CSD, Payments and Banks are closed.

**2 May – Bridge Holiday:** Substitute working day is 17 May, 2025 (Saturday). Banks and the CSD are open while the Stock Exchange is closed.

17 May – substitute working day: Banks and the CSD are open with limited opening hours, while the Stock Exchange is closed.

## Romania

**1 May – Labour Day:** Stock Exchange, CSD, Payments and Banks are closed.

#### Russia

**30 April –** Due to the forthcoming public holiday in Russia AO UniCredit Bank's cut-off time for custody instructions will be 16:30 (Moscow time).

1 May – Labour Day: Stock Exchange, CSD, Payments and Banks are closed.

**2 May - Labour's Day Holiday:** AO UniCredit Bank will be closed and will resume its normal operations on May 5. 2025. Stock Exchange and CSD will be opened with limitations.

#### Slovakia

**1 May – Labour Day:** Whole market is closed. Only CSD is opened but its services are limited to FOP settlement instructions and electronicly submitted service requests to Information System.

**8 May – Victory Day:** Stock Exchange and Banks are closed. Local payment system and CSD are open. Depository service is restricted to settlement of instructions in settlement system and electronic submission of requests to Information System.

#### Slovenia

1 May – Labour Day: Stock Exchange, Payments system and Banks are closed. CSD will be open for OTC free of payment settlements.
2 May – Labour Holiday: Stock Exchange and Banks are closed. CSD will be open for OTC settlements.
