14 May – Ascension Day: Stock Exchange, CSD, Banks (Limited) and payment systems will be open. Settlement supported by UCBA (against and free of payment)

25 May – Whit Monday: Stock Exchange, CSD, Banks (Limited) and payment systems will be open. Settlement supported by UCBA (against and free of payment)

Bosnia and Herzegovina

1 May – Labour Day: Stock Exchange, CSD, Banks and payment systems are closed.

27 May – Eid-al-Adha/Hajj: Stock Exchange and CSD are closed, while Banks and payment systems will be open. Federation of BiH holiday only. Neither trading on SASE nor settlement in FBiH will take place. This is a normal working day for the market in the Republic of Srpska.

28 May – BLSE Conference - Due to the Conference marking the 25th anniversary of the founding of the Banja Luka Stock Exchange, there will be no trading on the Banja Luka Stock Exchange on May 28, 2026. CSD, Banks and Payment Systems will be open.

Bulgaria

1 May – Labour Day: Stock Exchange, CSD, Banks and payment systems are closed.

6 May – St.George's Day: Stock Exchange, CSD, Banks and payment systems are closed.

25 May – Public Holiday: Stock Exchange, CSD, Banks and payment systems are closed.

Croatia

1 May – International Workers' Day: Stock Exchange, CSD and Banks are closed.

Czech Republic

1 May – May Day (Friday): Stock Exchange, CSD and Banks are closed.

8 May – Liberation from Fascism (Friday): Stock Exchange, CSD and Banks are closed.

Hungary

1 May – Labour day: Stock Exchange, CSD and Banks are closed.

25 May – Whit Monday: Stock Exchange, CSD and Banks are closed.

Romania

1 May – Labor Day: Stock Exchange, CSD, Banks and payment systems are closed.

Russia

30 April – Due to the forthcoming public holiday in Russia AO UniCredit Bank's cut-off time for custody instructions will be 16:30 (Moscow time).

1 May – Labour Day: Stock Exchange, CSD, Banks and payment systems are closed.

8 May – Due to the forthcoming public holiday in Russia AO UniCredit Bank's cut-off time for custody instructions will be 15:15 (Moscow time).

11 May – Victory's Day's Holiday: Banks and payment systems are closed, while Stock Exchange and CSD will be open with limitations.

Serbia

1 May – Labour Day: Stock Exchange, CSD and Banks are closed.

Slovakia

1 May – Labour Day: Stock Exchange, Banks and payment systems are closed, while CSD will be open, but its services are limited to FOP settlement instructions and electronically submitted service requests to Information system.

Slovenia

1 May – Labour Day: Stock Exchange, Banks and payment systems are closed, while CSD (Limited) will be open. No DVP settlement only FOP
