

INFORMATION FOR THIRD PARTIES

PURSUANT TO SECTION 13 OF ITALIAN LEGISALTIVE DECREE 196 OF 30/6/2003

(PERSONAL DATA PROTECTION CODE)

We wish to inform you that, pursuant to section 13 of Italian Legislative Decree 196/2003, your personal data will be processed and specifically:

- a) the purposes of this processing are related to the execution of obligations arising from the contractual relationship established or being established with you and to all tasks directly related to it, as well as from legal, regulatory and European legislation obligations;
- b) data processing methods may include printed matter, information technology to store and manage the data, and the use of suitable tools to ensure data security and confidentiality;
- c) your data may be subject to disclosure, in full compliance with legal requirements, for purposes strictly related to the execution of our contractual obligations;
- d) employees and/or collaborators who need to have knowledge of your data for the performance of their tasks and third parties who perform activities related and instrumental to the same processing on behalf of **UniCredit Business Integrated Solutions S.C.p.A.** may be privy to this data as persons tasked with processing, data controllers or data processors.

May we remind you that section 7 of Italian Legislative Decree 196/2003 recognizes your rights. Specifically you can:

- obtain confirmation of the existence or not of personal data concerning you and that such data is communicated to you in a comprehensive form;
- know the source of the data, the purpose and processing methods, the rational applied to electronically processed data, the identity of the data controller and data processor, the subjects and category of subjects that may be privy to the data or to whom it may be communicated;
- obtain updating, correction or integration of data, when required; obtain erasure, transformation into an anonymous form or blocking of data processed in violation of the law; obtain confirmation that such operations have been brought to the attention of those to whom the data was communicated or disseminated (where this is not impossible or disproportionate to the right protected);
- object, in whole or in part, for legitimate reasons to the processing of personal data even if pertinent to collection purposes or when data is process for the purposes of direct sales, market research, commercial communication or the sending of advertising material.
