

## INFORMATION NOTICE TO THIRD PARTIES

**PURSUANT TO THE ARTT.13 AND 14 TO THE GENERAL REGULATIONS ON THE PROTECTION OF PERSONAL DATA - REGULATION (EU) 2016/679 (HEREINAFTER ALSO GDPR), RELATED TO THE PROTECTION OF PHYSICAL PERSONS WITH REGARD TO THE ROCESSING OF PERSONAL DATA**

UniCredit Services S.C.p.A. informs you that your personal data, collected directly from Data Subject (You) or from third parties, may be processed, even by third companies (also located abroad) acting as Data Processors:

1. to comply with provisions imposed by laws, regulations and EU legislation, or provisions imposed by Authorities entitled by law. The provision of personal data necessary for these purposes is mandatory and their processing doesn't require your consent.
2. purposes strictly connected and instrumental to completion and execution of the supply of goods and/or services agreement between UniCredit Services S.C.p.A. and the Data Subject. The provision of personal data necessary for these purposes is not mandatory, but your denial may mean the impossibility of drawing up of the supply of goods and/or services agreement with UniCredit Services S.C.p.A.. Their processing doesn't require your consent.

Processing is carried out using manual, computer and telematic systems with a logic strictly related to mentioned purposes and, in any case, to ensure security and confidentiality of data.

UniCredit Services S.C.p.A. – without consent of Data Subject – may disclose personal data to subjects whom such communication must be made to fulfill an obligation imposed by law, regulation or EU legislation.

May become aware of your personal data, as Data Processors, natural and legal persons included in the list mentioned in next paragraph and, as persons in charge of processing (relative to the data necessary for the performance of their assigned duties), natural persons included in the following categories: UniCredit services S.C.p.A. employees or seconded, temporary workers, interns, consultants, employees of external companies acting as Data Processors.

The General Data Protection Regulation (EU Regulation 679/2016) assigns specific rights to the data subject, including the right to know the data concerning him in possession of UniCredit Services S.C.p.A. and how they are used (Right of access), to obtain the updating, the correction or if there is interest, the integration, the portability of data, as well as the cancellation, transformation into anonymous form or limitation etc. Finally, the interested subject, may at any time oppose the processing aimed at sending commercial and advertising material, direct sales or market research.
