

## **INFORMATION PURSUANT TO ARTT. 13 AND 14 OF REGULATION EU 2016/679 (GDPR)**

UniCredit S.p.A. (hereinafter "**UniCredit**") with registered office in Milan, Piazza Gae Aulenti 3, Tower A - 20154 Milan, informs you, as **Data Controller** and in compliance with EU Regulation 2016/679 ("GDPR"), that it will process your personal data (image, name, surname, job role and city) ("**Personal Data**") for the production of photographic and video material containing your Personal Data created in the context of the Event "**Contribution for OneUniCredit**" (hereinafter referred to as "**Event**").

The pictures and/or video recordings produced during and subsequently to the Event and containing your Personal Data (hereinafter the "**Material**") processed by UniCredit will be published by UniCredit on the various communication channels used by UniCredit, online and offline (e.g. Group Intranet and Group Institutional website) and / or social networks (including YouTube, Facebook, Twitter, etc.), the UniCredit Group's websites/apps and / or of third parties and during demonstrations, meetings, etc. In case of processing of your Personal Data, published on websites, by way of example, such as LinkedIn, Facebook, YouTube, Twitter, taking into consideration that these website are managed by third parties of which UniCredit has no control, please be aware that the erasure of your Personal Data could be impossible since it would require disproportionate effort (e.g. the erasure would be very costly and/or technically challenging).

The **legal ground** for data processing is your consent. You are under no obligation to give your consent for the purposes indicated above, and you can choose not to grant such consent without any prejudice to your rights – it simply means that your Personal Data cannot be used in the Material for the purposes outlined above. You have the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

The data will be processed electronically (or in any case automated) and manually, granting the confidentiality, correctness and security of the data. UniCredit in fact guarantees the use of all security measures, technical and organizational measures adequate to ensure a level of security appropriate to the risk, pursuant to art. 32 of the aforementioned Regulation EU 2016/679.

Furthermore, UniCredit would like to inform you that artt. 15-22 of the aforementioned Regulation recognizes you certain rights over your Personal Data, such as the right to ask which of your data are processed by UniCredit, how they are used and, when provided for, the right to have a copy of the data and/or their erasure, update, rectification or completion as well as the cancellation, transformation into anonymous form or limitation. UniCredit informs you that you have the right to lodge a complaint with or make a report to the Authority for the Protection of Personal Data, and/or the right to an effective judicial remedy. **UniCredit retains your Personal Data for a maximum period of 36 months starting from the date of issue of your consent (as indicated below).**

Your Personal Data related to your image may be processed by the natural persons belonging to the following categories of persons authorized to process personal data, with regard to the data necessary for the performance of the duties assigned to them: Bank employees or seconded by it; temporary employees, interns, consultants and employees of external companies appointed as Data Processors .
