Code for the Protection of Personal Data

Statement of Information Concerning the Use and Protection of Personal Data

Pursuant to Italian Legislative Decree 196/2003 UniCredit, with registered headquarters in Genoa, Italy, at the address of Via Dante 1, in its capacity as “Controller” of the use and processing of personal data, provides the following information concerning utilisation of personal data acquired from participants in the competition indicated above:

- 1) The said personal data will be used solely for the purposes of the competition for assignment of the research contract.
- 2) To this end there must also be communication to the members of the Board of Examiners, the list of which is at candidates’ disposal at the “GIOVANNA CRIVELLI” Competition Secretariat c/o UniCredit – Direzione Centrale – Direzione Risorse Umane, Gestione Personale – Via San Protaso 3 – 20121 Milan – Italy, solely of those data that, based on the competition’s rules, are of interest to the Board of Examiners for the operations for which it is responsible.
- 3) Use and handling of personal data will take place via utilisation of manual and computerised instruments according to a logic strictly connected with the purposes for which such data have been acquired, and in any case in such a way as to assure their security and confidentiality.
- 4) Candidates will be able to exercise the specific rights recognised by Article 7 of Italian Legislative Decree 196/2003 – among which we recall the right to receive confirmation of the existence or otherwise of their data; the right for such data to be made available in a comprehensible form; the right to know the logic and purposes on which use and processing are based; the right to obtain erasure, transformation into anonymous form, or the blocking of data used and processed in breach of the law, as well as the updating, correction or, if of interest, supplementing of data; and the right to oppose, for legitimate reasons, the use and processing of the data – by writing to the Personal Data Processing Officer.

- 5) Consent to the data's use and processing and to their communication – within the limits specified earlier – to the persons indicated above is indispensable in order to perform the operations envisaged by competition rules for assignment of the scholarships. Without such consent it will be impossible for the candidate to take part in the competition.
- 6) The Personal Data Processing is the current Human Resources Manager (Responsabile della Direzione Risorse Umane) at the Head Office (Direzione Centrale) in Milan at the address of Via San Protaso 3.
- 7) Further information can be requested from the “GIOVANNA CRIVELLI” Competition Secretariat c/o UniCredit – Direzione Centrale – Direzione Risorse Umane, Gestione Personale – Via San Protaso 3 – 20121 Milan – Italy.

Candidates are asked to refrain from providing details from which it might be possible to deduce, among other things, their racial and ethnic origin, religious beliefs, political opinions, and membership of political parties, trade unions, and associations or organisations of a religious, political, or union-related nature, as well as their state of health, i.e. data that Italian Legislative Decree 196/2003 defines as “sensitive”.

Such data are in fact irrelevant for the purposes of participation in the competition and cannot be used and processed without authorisation from the Italian Guarantor for the Protection of Personal Data.
